## Cybersecurity and humanitarianism: Opportunities and challenges

Sanjana was invited to speak on a panel on Humanitarian Threats in the Age of Cyberwar and to kickoff a workshop on Taking Stock and Making Plans with Peter Maurer, President of ICRC. In this first panel, humanitarian thinkers and cybersecurity leaders sat together to synthesize and reframe the day's learnings, and to explore emerging threats to civilian populations. The panel was moderated by Joseph Guay, The Policy Lab and also featured Eva Galperin, Electronic Frontier Foundation, Jeff Moss, DEF CON, Paul Nicholas, Microsoft and Nathaniel A. Raymond, Harvard University.

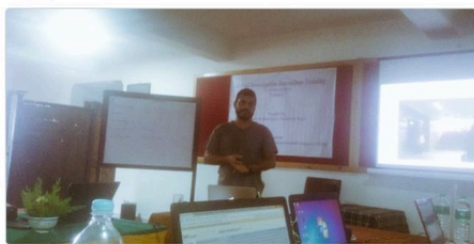


## Strengthening media and civil society capacity in Afghanistan

Sanjana Hattotuwa, Special Advisor at the Foundation, has travelled to Kabul at least once a year since 2015 at the invitation of Internews to conduct workshops on strategic communications, social media and digital security with a range of leading mainstream media organizations, journalists and civil society activists from around the country. The underlying rationale for these visits is to develop local capacities to use new and social media to bear witness to Afghanistan's contemporary politics, society and governance. The work also strengthens resilience of key actors within the country to keep doing what they do even in the most austere of contexts, and is anchored to developing business continuity in the media sector, so that critical operations can continue even in the face of debilitating violence.

## Digital Investigative Journalism in Nepal

Sanjana Hattotuwa, Special Advisor at the ICT4Peace Foundation, was invited by the Centre for Investigative Journalism Nepal to support a workshop for leading journalists from around the country in the use of online, social and digital media in investigative journalism. Sanjana taught two days of a four day workshop, and focussed on social media strategies for bearing witness to, and communicating inconvenient truths, the use of film, audio and photography in media campaigns including in cross-platform investigative stories, and the importance of social media engagement in a country that now has eight million monthly Facebook users alone, leave aside those on Twitter, Instagram and using instant messaging apps.

Sanjana Hattotuwa, Special Advisor at the ICT4Peace Foundation, was invited to be of the panel of jurists at the Resonant Voices Hackathon, held in Durrës, Albania from [14-17 September 2017](#).

The [Resonant Voices](#) initiative aims to challenge extremist narratives in public discourse throughout the Western Balkans - in particular those disseminated online - and to equip critical voices in the target countries with the skills, know-how and resources to counter radicalisation, the recruitment of foreign terrorist fighters and violent extremists and other dangerous trends. It will also empower a diverse group of civil society actors - activists, journalists, bloggers, educators and other online (and offline) influencers - to become resonant voices, able to counter violent extremism, to push back against extremist propaganda and to increase and amplify alternative, positive messages.

ICT4Peace is a policy and action-oriented international Foundation. Our purpose is to save lives and protect human dignity through Information and Communication Technology.

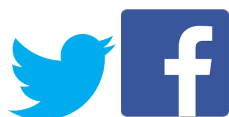

ICT4Peace took root with pioneering research on the role of ICTs in preventing, responding to and recovering from conflict in 2003 and lead to the adoption of Paragraph 36 by the World Summit on the Information Society (WSIS) in Tunis in 2005 which recognises “...*the potential of ICTs to promote peace and to prevent conflict which, inter alia, negatively affects achieving development goals. ICTs can be used for identifying conflict situations through early-warning systems preventing conflicts, promoting their peaceful resolution, supporting*

*humanitarian action, including protection of civilians in armed conflicts, facilitating peacekeeping missions, and assisting post conflict peace-building and reconstruction".*

The **ICT4Peace Foundation** works to promote the practical realisation of Paragraph 36 and looks at the role of ICT in crisis management, covering aspects of early warning and conflict prevention, peace mediation, peacekeeping, peace-building as well as natural disaster management and humanitarian operations.
